



## ADDITIONAL INFORMATION AND WHAT TO KNOW BEFORE YOU GO!

### PARKING & TRAMS

Parking is not included in the event ticket price. We recommend that you park in the Mickey & Friends and Pixar Pals Parking Structures. We ask that you please hold on to the respective Parking Structure ticket from our toll booths, ensuring in and out privileges throughout the day. At the conclusion of the event, Mickey & Friends and Pixar Pals Parking Structure Trams will operate until 5:00 a.m.

### EVENT CHECK-IN

Event check-in will take place in the Magic Kingdom Ballroom at the *Disneyland*<sup>®</sup> Hotel from 9:00 a.m. to 11:00 p.m. based on your paid event date. Please be prepared to show photo identification in order to check-in for the event. As a reminder, Event Guests may not check-in for another event Guest.

### DISNEYLAND<sup>®</sup> HOTEL EVENT VENUES

Event credential and wristband (distributed at event check-in) are required to enter all hotel event venues on your paid event date. Please note: separate theme park admission is required to enter *Disneyland*<sup>®</sup> Resort theme parks prior to the event.

### DISNEYLAND<sup>®</sup> PARK EVENT VENUES

Event credential, wristband and event park ticket (distributed at event check-in) will be required upon entry into the event in *Disneyland*<sup>®</sup> Park after Midnight on your paid event date. Please note: separate theme park admission is required to enter *Disneyland*<sup>®</sup> Resort theme parks prior to the event.

### RANDOM SELECTION PROCESS (RSP) MERCHANDISE PICK-UP

Pre-purchased merchandise may be picked up in the South Ballroom at the *Disneyland*<sup>®</sup> Hotel, located on the first floor of the convention center from 9:00 a.m. to 11:00 p.m. on your paid event date. As a reminder, Guests may not pick-up Random Selection Process merchandise for another event Guest.

### EVENT STORE

Remaining inventory of merchandise items not awarded during the Random Selection Process will be available to purchase at the Event Store, while supplies last, on your paid event date. Purchase limits will apply.

Limit TWO (2) items signed per Artist, per Guest. Special Appearance guests will only sign their respective merchandise. We ask that you bring no personal items to be signed. Merchandise must be purchased in conjunction with *The Haunted Mansion: Celebrating 50 Years of Retirement Unliving* event. Merchandise receipt may be required. ### FOOD & BEVERAGE

The event credential will include four (4) coupon tabs. Each credential coupon is valid for one (1) food or beverage item under the applicable category, excludes novelty items. Categories are as follows: Graveyard Snacks, Haunted Hors d'oeuvres, Ravenous Desserts and Tempting Beverages. These credential coupons are valid on the respective event date and time only at *Disneyland*® Park. Credential with attached coupon must be presented at participating food & beverage event locations which will be indicated in the Event Guide Map to receive select food or beverage items in exchange for the coupons. Coupons must be attached to the credential at time of redemption and surrendered to a Cast Member at time of use; void if detached.

- Limited Vegetarian menu offerings are available at select locations.
- Kosher available at select locations upon request.

### GUEST LOCKERS & STROLLER/WHEELCHAIR/ECV RENTALS

Guest lockers on Main Street and near the Main Entrance to *Disneyland*® Park will be available for rental until 4:00 a.m. on your paid event date. Lockers will be cleared out accordingly after 4:30 a.m. Strollers, wheelchairs and ECV's will also be available for rental, while supplies last.

### EVENT ATTIRE

We ask that you please dress comfortably as portions of the event will take place inside and outside. Haunted Mansion themed attire is acceptable. Costumes Guidelines apply, see below.

#### Costume Guidelines

- All Guests may dress as their favorite character during the event, but may not pose for pictures or sign autographs for other Guests.
- Costumes must be family-friendly and may not be obstructive, offensive, objectionable or violent.
- Costumes may not contain any items that resemble (or could easily be mistaken for) an actual weapon.
- Costumes may not contain sharp/pointed objects or materials that may accidentally strike another Guest.
- Layered costumes or costume props that surround the entire body are strongly discouraged and may be subject to additional security screening.
- Costumes may not reach or drag on the ground (e.g., full-length Princess dresses).

#### For Guests Ages 13 and Under

- Costumes and some masks may be worn as long as the entire face isn't covered and eyes are visible.

#### For Guests Ages 14 and Older

- Capes may be worn if the length does not go below the waist.
- Themed T-shirts, blouses, sweatshirts and hats are permitted.
- Headwear may be worn as long as it does not cover the face.
- Masks of any kind may not be worn, except for medical purposes.
- Guests who do not adhere to these guidelines may be refused entry and/or removed from the event, unless his or her costume can be modified to meet the above standards.
- While creativity is encouraged, we also value safety and good judgment. The above rules apply only during event hours—standard theme park attire rules apply during all other times. All rules, regulations and guidelines are subject to change without notice.
